2023/071 Questions from Residents

2023/071.1Resident: Invited by Councillors to provide an update on the engineering of the wetlands Consultation has taken place and the applicant has responded.

The Environment Agency has objected to the application as to close to the river, and to its size. South East Water strongly object. The development would sit in source protection Zone 1, these protect waste infiltration into ground water extraction site. Purpose of the zones are to safeguard water quality. A risk assessment has been asked from the applicant. South East Water opposed the application due to pollution to the water supply. Applicant has responded that the 6 ponds created will be lined ,the lining should last 100-125 years. Councillor G Meaden asked to call in the application as a ward Councillor for Ashford Borough Council.

2023/071.2 The Environmental policy was developed as a result of the Branch road Surgery and dispensary closure and was supported by over 750 parishioners. Will you please restore the item in the section 5 where it is not defined please. When it is reindorsed one would expect it has to be taken to ABC to be embedded in the Planning framework for all new build and new utility services subject to planning control.

The clerk provided a response by email previous to the meeting and attached the planning explained document, Campaign to protect rural England, bringing to attention the following:

'So, if you want to have your say in plans for the future of your city, town, village or neighbourhood it is important to get involved in the Local Plan.' Pg 14

Town and parish councils and the public have an important role to play in the Local Plan process. They are all invited to participate by making comments (sometimes referred to as 'representations') on the draft plan. They may also be invited to participate in a consultation event, make comments at a roadshow or in response to a leaflet, or get involved in a citizens' panel. This guide will help you think about what you want to say, and to make your comments in the most effective way.'

As the local plan is not currently open to negotiation the policy as such will not be adopted by Ashford Borough Council. Councillors will be asked to consider whether the policy how they wish to proceed with the Environmental policy.

The agreed action, 2023/058.2, were confirmed

2023/071.3 The Chilham wood comment quote "it is understood all work has ceased as it was illegal." Why does the CPC tree warden supersede the tree authority in ABC this should be clarified to all concerned to avoid risk of innocent prosecution as implied by the lack of knowledge by the owner. Our ward member was quoted as stating the officer has instructed all work to stop and as procedures had not been followed and were detrimental to the wood and may be an offence. Is it an offence as it is stated or not?

Phil Cook, Tree Warden for Ashford, has emailed the following in regards to the work on Mabel's Wood. 'I will provide the factual elements as far as I may, this is an ongoing investigation so not all of the information has been established.

- The work has ceased and will not re-start without any proposal being assessed and the requisite permissions/notifications sought.
- The arborist has cleared dead, fallen and dangerous trees from the site. Having looked at the stacks of timber I cannot find any trees that would have not been permitted to be felled either as an exemption to the need for an application or a 5 Day Notification. In my view, no good quality healthy trees have been felled.
- Whilst it is noted that pockets of saplings and younger trees have been left, the impact
 of the machinery where it has scraped away the bramble and Ivy needs to be
 assessed along with any potential remedial actions.'

Before the work commenced the opinion of the Tree warden for Chilham was sought for advice. At no point has it been suggested that the Chilham Tree warded supersedes Ashford Borough Council Tree Warden.

2023/071.4 Is THT sampling of water to be disregarded or sent to Castle Water for action. The questions raised regarding the water supply have been clarified by the contractor. The report does not recommend any further action regarding supply, and this has been accepted by the Parish Council.

2023/072 Borough Councillors, Policing: Ward Member's report to Chilham PC

I must give a major thank you for those who voted for me at the recent local council elections. It was good to know that I was clearly doing something right because this is not always easy to tell. I hope that I can continue thus and remember that it is important for residents to make contact with me if they have any local concerns.

Could I just add that there a few things that I can do little about and probably the most important of these are the potholes. I'm afraid that these are a KCC matter and I have been told that the situation is likely to remain quite severe for a long period as the resources for fixing these are severely limited. However, can I remind parishioners that there are a range of public problems that can be brought to the attention of either KCC or ABC via online reporting. As well as potholes these include matters such as blocked drains, hedges or trees that need attention, burst water pipes, fly-tipping, some building repairs, noise nuisances, etc.

Another problem that is proving difficult to resolve is that of over-hanging hedges. I can think of three or four hedges that I have issued complaints about to ABC but they have claimed that inspections have shown these hedges are not in fact a problem. But when is a problem a problem? To my mind the hedge opposite Dave Cawdron's garage on the Street in Chilham, which is blocking movement of the rubbish cart up this street is definitely a problem, as is the hedge in North Downs Close, in which a street light is "buried", is also a problem.

But much of my time seems to be devoted to two major planning developments both of which are in the Chilham area, i.e. the large solar farm proposed near Old Wives Lees and the artificial wetland proposed at the edge of Chilham. Both proposed plans are taking many months to address because they are contentious, complex and of a major scale. My main concern with these plans are that they are likely to be determined by national governmental dictates rather than by local interests. It seems to me that national interests are very much detached from local knowledge and local needs. So, I fear that the plan for a wetland development on the Stour near Chilham, may be permitted as the need for an urgent upgrade of water quality is necessary. But in my view the water quality issue should be addressed at source by cleaning up the sewage discharges and reducing chemical runoff from mainly farming sources. Similarly, with the respect to the solar farm, I fear that a distant national government will see that meeting their energy targets is more important than other local, national and indeed international needs and considerations. Obviously, when there are so many alternative solutions to the resolution of the climate crisis, then the answer must be a tricky balance, but in our case I believe that this balance may not be correctly struck in a manner that is appropriate to our local circumstances.

Finally, as a result of the first meeting of the new Council on Ashford Borough, held on Tuesday evening this week, the ruling cabinet of the new Borough Council is likely to consist of one Conservative, five Ashford Independents and four Green Party members. This will be a huge contrast in respect to the former situation where only one of these groups was represented. There will be a huge learning curve for many of
