Ward Member's Report (July 2024)

Not a great deal to report this month mainly because the Ashford Borough Council's routines have been interrupted by the General Election, which involves the Council with lots of extra work, and with ABC trying to cope with the effect of introducing a completely new waste and recycling company who were not well prepared for the complications that might arise. I gather that the Council had been receiving literally thousands of queries and complaints.

I had a meeting with two senior Planning officers to discuss what I consider to be completely inadequate protection being given to the conservation of "Green" spaces in the Borough. Thus, under the Local Plan the Borough is able to identify land required to accommodate necessary housing, retailing and employment growth, but there are no requirements to give "sanctuary for nature". So, we see all sorts of green land being abused and this goes on in a country which is already the most "de-natured" in Europe. Slowly, this situation is being recognised, e.g. via the recent "Making Space for Nature" initiative, but this is not enough and as a society we need far more urgent action. The ABC officers I spoke to were entirely sympathetic and have promised to take this "green protection" issue up with others in the Planning office. I sincerely hope that progress is made.

One unusual matter to mention was the receipt of an email which read as follows:

"Dear Sir, As a tourist I visited Chilham and I was very thankful to be able to see and feel such pristine quietness. If Chilham could just remain the wonderful green treasure as it is now that would be the absolute greatest decision for now and for future generations who are thanking you now. Kind regards and thank you. Mark van Santbrink."

I thought this to be such a charming and perceptive observation.
